**I. *Call to Order***

Commissioner Castagno was present and called the meeting to order at 9:11 A.M. Commissioners Salvatore Bramante and Michael Ajello were present. Commissioner Stephen Penny joined the meeting at 10:19 A.M.

**II. *Approval of the Minutes***

*Approval of the Minutes of the Meeting of August 18, 2015*

It was moved by Commissioner Ajello and seconded by Commissioner Bramante to approve the Minutes of the August 18, 2015, Regular Meeting, as amended by a 3-0-0 vote.

*Approval of the Minutes of the Meeting of August 21, 2015*

It was moved by Commissioner Penny and seconded by Commissioner Ajello to approve the Minutes of the August 21, 2015, Special Meeting by a 3-0-1 vote. Commissioner Bramante abstained from voting.

**III. *Administrative Reports***

Executive Director Brandi noted that as of today, the Commission is on track with regard to budget and operating issues. We are very carefully monitoring all of our expenditures.

SEEC has a significant move going on right now as we are moving more of our servers and equipment to the Groton Data Center. We will hopefully have a complete move of all of our existing equipment by the end of this month. We are trying to have as much of this done and tested prior to the October filings.

SEEC is fully staffed with the exception of our one Information Technology Manager position which we are just waiting on some issues to resolve.

Staff is still pulling together our Legislative Agenda. SEEC hopes to reintroduce the Coordinated Expenditure language as part of the Commission's recommendations.

That was the language in the Legislation SEEC proposed last year which did make it out of committee and are hoping to reintroduce again this year.

SEEC staff have a number of conferences and meetings coming up for fall. A lot of trainings coming up, both CEP trainings for next year and finishing up municipal trainings for the current cycle. Presentations are coming up in October with the League of Women Voters on voter fraud and in December, the national COGEL conference in Boston of which many Commission will be presenting.

Tomorrow is primary day, and SEEC will have the hotline open early tomorrow morning and going all day for the public to contact us with any issues. Staff will be carefully monitoring that in consultation with the Secretary of the State and other agencies.

The Enforcement Unit has already received a number of complaints. There have been a sizeable number coming in from several municipalities and we will present those later in the meeting during executive session.

Commission staff is doing major preparation work for the Municipal Pilot Program and will be attending the Town Clerk's conference later this month and discussing the program with the clerks. We are looking to bring the application process to the Commission to finalize in the next month.

Commissioner Bramante inquired as to the status of the Citizens' Election Fund for the 2016 election.

As of today the balance of the fund is around 10 million. SEEC did receive in late August approximately a 2 million deposit into the fund. We are scheduled for this fiscal year to receive approximately 11.4 million into the fund. So with the total deposits to be made in addition to the current balance SEEC should have close to 19 to 20 million dollars available for the 2016 General Assembly race. SEEC will have sufficient monies to get through the next election cycle.

In Fiscal Year 2017 an additional \$7.75 million is anticipated to be moved from the Citizen's Election Fund to the General Fund. At that point SEEC will look to either reverse the sweep or to replace those funds in order to have funds available for the 2018 statewide and General Assembly races.


**VII. Adjournment**
