the commission the most flexibility with managing the one year limit the staff have to close a newly filed complaint.

Executive Director Brandi reported that there have already been 80 complaints filed in 2018 and more are expected as the 2018 general election comes and goes. Staff have been working hard to monitor and move the cases falling under this one year provision, and are currently focused on those complaints which came in during the first quarter of 2018.

Commissioners suggested that the SEEC suggest a legislative change to allow for more time when a case goes to hearing.


The commission announced that the meeting for September 18, 2018 is being cancelled.
