I. Call to Order

Commissioner Anthony Castagno was present via teleconference and called the meeting to order at 4:00 P.M. Commissioners Stephen Penny, Michael Ajello and Patricia Stankevicius were present via teleconference. Commissioner Salvatore Bramante was present. Agency staff was also present.

II. Executive Session per General Statutes §§ 1-200(6)(B) and (E), and 1-210(b)(1),(3),(4),(10) and General Statutes §9-7a, as amended by Public Act 11-48 §300 (Preliminary draft and agency consideration of enforcement action and exempt records relative thereto)


The Commission expressed their regrets that they cannot review the application packages because they were not timely filed and that they therefore cannot be considered by the Commission.
