I. Call to Order

Commissioner Castagno was present and called the meeting to order at 9:30 A.M. Commissioners Bramante, Penny and Ajello were present. Agency staff was also present.

Commissioner Castagno made a few changes to the agenda as follows: add items # 7 in public session for file number 2017-071 and item IV.A.2. file number 2014-143 moved to 1a in executive session.

II. Approval of the Minutes

III. Administrative Reports

1. SEEC 2018 Legislative Proposals

The 2018 Legislative Session opened February 7 and the State Elections Enforcement we are working with the legislature to preserve and possibly expand our funding. Legislative correspondence – we received a request from the Bridgeport Town Committee Primary – concerns about the absentee ballot procedure and overall process. There is a special election scheduled for April 10 and the SEEC and SOTS have been requested as elections monitors. SEEC has respectfully declined, since monitoring is in the purview of the SOTS. Director of Elections Peggy Reeves is confident the fail safes are in place

Legislative proposals, CEP forum last week which rendered a good discussion with Common Cause and Democracy Alliance. SEEC has submitted four

proposals which include: 1) Dark money and disclosure, 2) protection of the CEF, 3) an act restoring CEP and 4) an act concerning the establishment by Party Committees of compliant accounts. The proposals are focused on the fights we continue to wage to protect our campaign finance rules and regulations. Commission was provided with a summary. Proposals will be presented to the GAE Committee. The fight to repeal the 1 year provision continues. Legal Programs Director Shannon Kief explained in greater detail the proposals

Executive Director and General Counsel Michael Brandi updated the commission on the 2018 budget. SEEC been running on a shoestring budget, but on track. Mark Severance will be joining us as the new Elections Officer and the Legal Investigator position has been posted and we will be interviewing in the next couple months.
